An intense program of talks and conversations takes you through the night. Starting at 7 pm, you will get a chance to hear renowned architectural historian Beatriz Colomina's talk "The Bed in the Age of Social Media." This will be followed by a host of other international artists, writers, philosophers, historians, and neuroscientists as they discuss sleeping and the cultural importance of dreaming, the meaning of downtime, the health impact of sleeplessness, and the philosophy, politics, and neuroscience of sleep.

"Ideas know no limit, and Night of Ideas will be a perfect boon for the curious and the restless in a global city, one that is more and more awake all night and sleep deprived," says Barbara Fisher, Executive Director / Chief Curator at the Art Museum.

"The Night grapples with what an ever-accelerating 24/7 world looks and feels like; unlike the more conventional formats, this event goes into, against and across disciplinary lines—in artworks, performances, music, film, and research across philosophy, literature, history and all the way through to neuroscience."
