SHIPPING

Borrowing unit is responsible for all associated costs. All shipping and installation is to be coordinated by the Art Museum.

INSURANCE

If Borrower provides Insurance, the Borrower shall furnish The University of Toronto Art Centre with a Certificate of Insurance evidencing coverage and naming The University of Toronto Art Centre as additional insured for the duration of the loan period. Such Certificate shall be provided to The University of Toronto Art Centre prior to shipment of the work.

Certificates of indemnification and Immunity from Seizure will also be furnished by the Borrower to the Lender as required, upon request.

INSURANCE

A. **Borrower Provides Insurance:** If the Borrower elects to provide insurance on the property, the Borrower agrees that the Art Centre or its representatives will not be liable for any loss of or damage to the property, for any error or deficiency in the information furnished to or by the Lender's insurers, or for lapses in coverage. The Borrower will insure the property while in transit to and from the Art Centre and while in its custody, i.e. "wall to wall" or "nail to nail", for the insurance value stated on the face of this Loan Agreement, against all risks of physical loss or damage from any external cause during the period of the loan. In addition, the Borrower must provide the Art Centre with a Certificate of Insurance. If in the event insurance coverage is maintained by the Borrower, the Borrower shall notify the Art Centre in writing of any change in coverage. The Borrower agrees to accept Canadian dollar value as of the date of this Loan Agreement

OR

B. **The University of Toronto Provides Insurance:** If the Borrower elects not to provide insurance on the property loaned by the Art Centre, the Art Centre will insure the property while in transit to end from the Art Centre and while in custody, under the University of Toronto Fine Arts Insurance Policy, i.e., "wall-to-wall", for the insurance value stated on the face of this Loan Agreement, against all risks of physical loss or damage from any external causes during the period of the loan. The Policy referred to includes the customary exclusions of such "all risk" policies, specifically excludes any framing, housing and the breakage of glass, but does include-damage done thereby. If the insured art is damaged by a professional Conservator, Restorer or Framer, the Insurer will cover the reasonable cost of repair and any depreciation directly caused by the damage.

1. If the Lender shall set a value for purposes of insurance for the period of the loan. Said value is not to be considered an appraisal. In the case of long-term loans, the Lender will advise the Borrower of any change In insurance evaluations.

2. If a work that has been industrially fabricated is damaged, and it can be repaired or replaced to the artist's specifications, the Borrower's responsibility will be limited to the cost of such repair and replacement

PHOTOGRAPHY AND REPRODUCTION

Under no circumstances is the Artwork loaned to be photographed, reproduced, or published for public or private use.

The Art Museum agrees to loan the Artwork described. The Borrowing Unit representative acknowledges that he/she/they has full authority and power to make this agreement and both parties have read the conditions above and on the reverse of this form and is bound by them.

TERMS AND CONDITIONS

1. The Borrower has requested to loan the Artwork listed in this agreement.
2. The Borrower will exercise the same care to the Artwork described on the face of this Agreement similar to property of his/her/their own.
3. Artwork on loan shall remain on display for the time specified in the Loan Agreement.
4. Loans may be terminated or renewed as determined by the Collections Manager and are subject to review.
5. The Director and his/her/their representative reserve the right to terminate this loan at any time.
6. The Borrower agrees to cover all costs associated with shipping, installation, framing, and moving of Artwork.
7. Once installed Artwork must not be moved or altered in anyway.
8. Any and all requests to move Artwork must be first submitted in writing, approved by the Art Museum and carried out by the Art Museum appointed staff.
9. The Borrower agrees not to photograph or reproduce the Artwork in any way. Artworks on loan are not to be sold or used in any way besides that which is outlined in this agreement.
10. Damage, including vandalism and theft, must be promptly reported to the Art Museum, described in detail and followed up in writing as a notification of loss.
11. The Borrower will inform the Art Museum of any changes in details, including but not limited to the change of name or address of department and individuals bound to this agreement.
